HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

- I. Water hazards in wading in the rivers including the possibility of being swept off of my feet, with the resulting possibility of being injured or even drowned.
- II. Hazards of hiking in rugged country, including slipping and falling.
- III. Injuries from fishing equipment and the actions of other participants.
- IV. Encounters with wildlife, including animals and insects.
- V. Temperature extremes, both anticipated and unanticipated, and other inclement weather conditions.
- VI. The unavailability of immediate medical attention in case of injury.

I understand and accept all of the known and unknown risks, hazards, and dangers of fishing and I assume such risks, hazards and dangers. I understand that these activities require good physical conditioning and a degree of skill and knowledge. I believe I have that physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
